The Resource Directory of Incentives for NCQA Clinical Recognition links clinicians to local financial and non-financial resources that support NCQA Recognition. The directory includes a list of public, private and multi-payer initiatives, by state, that support a variety of NCQA clinical Recognition programs including: Patient Centered Medical Home (PCMH), Patient Centered Specialty Practice (PCSP), Patient Centered Connected Care (PCCC), Diabetes Recognition Program (DRP), and Heart and Stroke Recognition Program (HSRP).

NCQA Partners in Quality

The directory also highlights organizations and initiatives that are designated NCQA Partners in Quality (PIQ). The PIQ program is available for organizations and initiatives that provide a specific set of resources and services that support practices in pursuit of practice transformation. NCQA PCMH Recognition

The NCQA Patient-Centered Medical Home (PCMH) Recognition program was launched in 2008 to provide a standardized tool for qualifying practices as adhering to the PCMH model. We have continued to evolve the model with PCMH standards 2011 and 2014.

This directory includes, if available, NCQA PCMH standards years (2011 or 2014) required by each organization or initiative to receive their support. NCQA PCMH 2011 standards are no longer available for submission but payers may still accept PCMH 2011 Recognition until a practice's status expires or it transitions to the 2014 standards. NCQA PCMH 2014 standards are available through 3/31/2017.







PCMH 2017. The PCMH 2017 release, will include updated standards and a redesigned practice Recognition experience, reduces documentation requirements and changes how practices will become recognized within the PCMH program. The new scoring structure will no longer use levels in determining recognition. Practices seeking PCMH Recognition will receive the designation by meeting the core requirements and a certain number of additional criteria. Practices will have the opportunity to demonstrate they meet some requirements during a virtual review of their practice during the recognition process. NCQA PCMH 2017 standards will be released in March 2017. There will be an overlap in 2017 while practices become familiar with new requirements. We will retire the PCMH 2014 standards at the end of 2017.
